

**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
UNIVERSITAS BRAWIJAYA, INDONESIA  
AND  
SIRTE UNIVERSITY, LIBYA**

In consideration of the wish of the Universitas Brawijaya, Indonesia and Sirte University, Libya and to establish cooperation within the framework of the academic exchange with the aim of promoting mutual academic cooperation and exchange.

This agreement entered into by and between:

**Universitas Brawijaya** (hereinafter “**UB**”), located at Jl. Veteran, Malang 65145, East Java, Indonesia, is a Public Higher Education Institution established in 1963 represented herein by its Rector, Prof. Dr. Ir. Nuhfil Hanani AR., MS. and shall include its lawful representatives and permitted assigns of the first party.

and

Sirte University (hereinafter “**SU**”) located at the main St., Sirte, is a Public Higher Education Institution established in 1989 represented herein by its President, Dr. Sulayman Alshatir and shall include its lawful representatives and permitted assigns of the second party.

**Whereas:** Parties agree to cooperate on academic programs based on equality and reciprocity;

**Whereas:** Pursuant to prevailing laws and regulations in their respective countries, as well as the procedures and policy of the Government of Indonesia and the Government of Libya concerning international collaboration on academic, scientific, and research cooperation;

**Therefore,** in consideration of the above, the Parties have decided to enter into a Memorandum of Understanding (MoU) which, from the date of its signature.

Parties agree as follows:

**Article One  
Objective**

The objective of the collaboration between UB and SU to promote mutual academic cooperation and exchange between two universities.

**Article Two**  
**Areas of Collaboration**

The two universities will jointly develop some or all of the following activities based on their respective academic and educational needs:

- a) Join and/or double degree program;
- b) Continuing study program for staff and students;
- c) Collaborative research;
- d) Postdoctoral program;
- e) Sabbatical leave program;
- f) Join conferences / seminars;
- g) Any other activities to be decided on the basis of mutual agreement by both universities.

**Article Three**  
**Financial Provision**

The terms and necessary budget for each program and project will be described in separate documents, which will be prepared subsequent to this Memorandum of Understanding and Letters of Agreement will be signed by both parties prior to the initiation of a cooperative program or project. A program may include one or more projects.

**Article Four**  
**Non-Binding Document**

- a) This MoU is not intended to be legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation between the Parties as described above.
- b) Nothing shall diminish the full autonomy of either party nor will any constraints or financial obligations be imposed by either upon the other in carrying out the memorandum of understanding.

**Article Five**  
**Duration and Termination**

- a) This memorandum of understanding is written in English, and the two universities shall keep copies of the memorandum of understanding. This memorandum of understanding becomes effective upon completion of the signatures, valid for a period of 5 years from the date of signing.
- b) This memorandum of understanding is subject to revision or renewal by mutual agreement.
